- Search terminals are available in the reception area of the District Clerk's office during regular business hours for public use. Regular Public business hours are Monday through Friday 7:30 A.M – 4:00 P.M. Closes during the noon hour 12:00-1:00 P.M, weekends and Holidays. Phone number is 830/796-4606.
- 2. The District Clerk's office will conduct searches (civil and criminal) covering the past 15 years for \$5.00 per name and/or document searched. For each additional year beyond the past 15 years add \$1.00 per year. Please allow two business days for results.

- 4. The cost for a copy of a document filed in a specific case is \$1.00 per page. Certified copies are \$1.00 per page plus \$5.00 for the Seal.
