Juvenile Probation Officers shall strive to carry out the goal of the Juvenile Probation Department to rehabilitate juveniles and protect the public. They shall uphold the dignity and worth of every individual and treat them with respect.

- * Supervision of juveniles and participating in programs for the juveniles to aid in their rehabilitation;
- * Intake decisions and investigations on juvenile referrals;

- * Participate in extended trips and activities;
